

Claire's/Alice in Wonderland – Terms and Conditions

1. The Competition is open to all residents of UK, ROI, Spain, Germany, France, Switzerland, Austria, Portugal, Belgium, The Netherlands aged 12 years or over (parental consent required for entrants under 16 years of age), except employees and families of Claire's Accessories and Walt Disney Studios Motion Pictures, their agents or anyone else professionally connected with this promotion.
2. Entries must be received between 15th February 2010 and midnight GMT on 21st March 2010 (the 'Closing Date'). Any entries received after this date and time will not be reviewed or judged.
